TERMS OF BOARDING		
1. All animals are boarded at owner's risk, but every care is taken 2. In the event of accident, illness, infectious or contagious disease consent is given by the undersigned for a veterinary surgeon to be called for any attention or treatment that is deemed necessary 3. Routine flea protection and worm eradication are the owner's responsibility. If fleas, ticks or worms are detected a suitable treatment dose of <i>Frontline</i> or <i>Drontal</i> will be given and charged for 4. Any excess damage will be charged for 5. Animals may be brought and collected only during the stated opening hours 6. All fees must be paid before collection of the animal 7. Non-collection without notification - after 7 days the animal will be considered abandoned and steps taken to re-home it 8. We have a cancellation policy which is available on website, displayed in office or ask for details 9. Data, including personal contact information, is collected and stored for purposes related to the kennel and animal care only 10. Photographs may be placed on the website, unless objection stated 11. The management reserve the right to refuse to accept an animal if considered unsuitable for boarding
